A. I hereby declare that I am a qualified voter of the Avoca Central School District and that on the election day of May 16, 2023, I will meet all four of the following criteria:

1. I am or will be over eighteen (18) years of age.
2. I am a citizen of the United States.
3. I have or will have resided in the Avoca Central School District for at least thirty (30) days.
4. I am a registered voter in the Avoca Central School District by virtue of having registered to vote with either the school district or my county Board of Elections.
